Objective:

To train more IAAC Peer Evaluators

Participants per Accreditation Body:

Participants in the New Evaluators Training Course were selected by the IAAC Peer Evaluators Management Subcommittee (PEMS) according to the criteria and procedures defined in document IAAC PR004. The course had 15 participants. The participants were appointed by the PEMS or by SAE (the local AB), which funded part of the expenses and provided the infrastructure for the course. The table below provides numbers of participants by accreditation body:

Training and organization improvements:

The program of the course included presentations by instructors, group exercises and an exam.

The course was taught in Spanish, as all participants were fluent in Spanish.



Participants were evaluated according to the criteria given in document IAAC PR 004 including: knowledge of ISO/IEC 17011:2004, IAF/ILAC A 5 MLA requirements, understanding of peer evaluation procedures, interpersonal skills, language skills for nonnative speakers, ability to work in groups and personal attributes.

Parts of the exam and its weighting:

- A) ISO/IEC 17011:2004 and IAF/ILAC A5 (40%),
- B) IAAC MD 002 (12%),
- C) Documents at the MLA main scopes level (8%),
- D) Peer assessment planning (8.5%),
- E) Activities during the peer assessment (11%),
- F) Activities after the peer assessment (20.5%).

Twelve (12) participants successfully passed the exam. Some of those who successfully passed the exam (that had been appointed by the PEMS) were approved to be qualified as trainee evaluators. The observers nominated by SAE (who were not qualified by PEMS as eligible to become trainee evaluators) that also met the requirements of the course by successfully passing the exam, may be qualified by PEMS as trainee peer evaluator once they meet the requirements for experience specified in PR004.

Participant surveys demonstrated a great level of satisfaction in each aspect. The highest level of satisfaction (level 5, from 1 to 5) was given by the participants in:

- Objective: 100%
- Fulfillment and contribution to development: 88,9%
- Topics: 77,8%
- Time, new knowledge, methodology and expectations: 55,6%
- Punctuality: 100%
- Instructors mastery and ability: 88,9%
- Relation with participants, encouraged participation and group interest: 77.8 %
- Congruence and availability to feedback: 66,7%
- Teaching aids: 55,6%
- IAAC Services 66.2 %
- Didactics aids, material and quality of presentations: 88,9%
- Training registry: 100%
- Attention during the training: 88,9%
- Organization: 77,8 %

The level 4 was selected in difficult to understand: 77,8%
